Vendor Registration or Advertising

Vendor spots are limited to 10 participants at Cody's Wild West Shootout, so it is advisable to register for a space as soon as possible. All vendors must check in at registration by 4 p.m. on Wednesday **before setting up**. Take-down will NOT begin before 3 p.m. on Saturday. You must supply your own tent and your own power (generator), if needed.

All vendors are responsible for collecting and paying Wyoming state sales taxes. Also, vendors are responsible for their own liability insurance and must sign a **Liability Release**. All displays should be of the period and vendors should wear period attire. Any display deemed inappropriate will be modified or removed. Food vendors should obtain a Park County Health Department certificate. There is no vendor fee, however, each vendor must fill out and submit this registration form by **May 14, 2010**.
